- 2. Authorizes the Chief Financial Officer to expend \$161,231.21 from Fund 700000, Muni Sewer Revenue Fund, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
