A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING THE REAPPOINTMENT TO THE SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY.

WHEREAS, California Public Utilities Code section 170010(a)(1) provides that the Mayor of the City of San Diego shall appoint three City residents to the board of directors (Board) of the San Diego County Regional Airport Authority (Authority), including two who shall be subject to confirmation by a majority vote of the City Council, and at least one who is an elected official of the City of San Diego; and

WHEREAS, California Public Utilities Code section 170011(a) provides that the term of office for a member of the Board is three years or until his or her successor qualifies and takes office, whichever date occurs last; and

WHEREAS, California Public Utilities Code section 170011(a) also provides that members of the Board take office at noon on the first Monday in February following their appointment; and

WHEREAS, the Mayor has appointed a citizen member, with a term that will end January 31, 2020, and seeks the Council's confirmation of the appointment; and

WHEREAS, the limits on the maximum length of service for board members set forth in Council Policy 000-13 apply to boards established under City Charter sections 41 and 43, and not to the Board of the Authority, which is established under and governed by state law, which does not state a term limit for service on the Board; and

WHEREAS, California Public Utilities Code sections 170010(a)(1) and 170010(d) require the Council's confirmation of the Mayor's reappointment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, pursuant to California Public Utilities Code sections 170010(a)(1) and 170011(a), that the following reappointment by the Mayor of the City of San Diego, to serve as a citizen member of the San Diego County Regional Airport Authority, for a term expiring as indicated, is made and hereby confirmed:
