A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A CONTRACT WITH PARKHOUSE TIRE INC., FOR THE REPAIR, MAINTENANCE AND REPLACEMENT OF HEAVY DUTY TIRES FOR THE CITY OF SAN DIEGO'S FLEET OF REFUSE AND RECYCLING PACKERS.

WHEREAS, the City of San Diego owns and operates a fleet of approximately 4,400 vehicles maintained by the Fleet Operations Department to support all City services; and

WHEREAS, on August 12, 2019, the City of San Diego's Purchasing and Contracting

Department issued an invitation to bid for Heavy Duty Tire Maintenance, Recapping, Inspection

Service and Tire Replacements to support the City's fleet of refuse and recycling collection trucks.

WHEREAS, Parkhouse Tire Inc.'s response to the invitation to bid established them as a qualified contractor who would provide the best overall value to the City for five years of comprehensive tire maintenance services. NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized to execute a contract with Parkhouse Tire Inc., in an amount not to exceed \$4,226,927 through Fiscal Year 2024 for the purchase of tires, tire maintenance, tire recapping, tire inspections and tire installation services for the City's fleet of refuse and recycling refuse packers.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$4,226,927 over the life of the contract, from the Fleet Operations

Operating Fund 720000, contingent upon the approval of the annual Appropriation Ordinance, the approval of the corresponding Fiscal Year adopted budget, and the Chief Financial Officer
