A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN SARA ALFARO AND THE CITY OF SAN DIEGO

WHEREAS, on April 20, 2018, SARA ALFARO filed suit against the City of San Diego [City] alleging damages resulting from discrimination and retaliation. Sara Alfaro brought suit in the Superior Court for the County of San Diego. The suit is entitled *Sara Alfaro vs. City of San Diego et al.*, San Diego Superior Court Case No. 37-2018-00019800-CU-OE-CTL [Litigation]; and

WHEREAS, in Closed Session on February 11, 2020, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, None; approved the settlement; and

WHEREAS, the City Council in Closed Session on February 11, 2020, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in a Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. A resolution authorizing the Mayor or his designee to pay the sum of \$525,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the Complaint.

2. Authorizes the Chief Financial Officer to expend \$525,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Department of Finance to issue a check in the amount of \$525,000.00, made payable to Manuel Corrales, Jr. in trust for Sara Alfaro, Client Trust Account for the benefit of Sara Alfaro.


