A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN PETITIONER, UNIVERSITY CITY COMMUNITY FOUNDATION, AND THE CITY OF SAN DIEGO.

WHEREAS, on May 9, 2018, Petitioner, University City Community Foundation (UCCF), filed suit against the City of San Diego alleging the City failed to comply with the California Environmental Quality Act (CEQA) because the Environmental Impact Report for the North City Pure Water Project - Phase 1 (Project) did not discuss a reasonable range of alternatives for the Morena Pipeline alignment. The suit is entitled *University City Community Foundation v. City of San Diego*; Superior Court Case No. 37-2018-00023240-CU-TT-CTL (hereafter "UCCF's CEQA action"); and

WHEREAS, on December 23, 2019, UCCF filed suit against the City of San Diego challenging the constitutionality of State Assembly Bill 1290 (AB 1290) which requires the use of project labor agreements as a condition of receiving construction financing under the Safe Drinking Water Revolving Fund Law or financial assistance from the State Water Pollution Control Revolving Fund for work performed for any portion of the Pure Water San Diego Program. The suit is entitled *University City Community Foundation v. State of California and City of San Diego*; Superior Court Case No. 37-2019-00068076-CU-MC-CTL (hereafter "UCCF's AB 1290 action"); and

WHEREAS, in closed session on January 28, 2020, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays: none; Absent, none, approved the settlement of UCCF's CEQA action and UCCF's AB 1290 action for an amount consistent with

the amount set forth below and pursuant to such other terms more fully set forth in a settlement agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$60,000.00 from Water Fund No. 700011, in settlement of each and every claim to costs and fees of any type, including attorneys' fees, against City of San Diego, its agents and employees, arising from *University City Community Foundation v. City of San Diego*; Superior Court Case No. 37-2018-00023240-CU-TT-CTL and *University City Community Foundation v. State of California and City of San Diego*; Superior Court Case No. 37-2019-00068076-CU-MC-CTL.

- 2. Authorizes the Chief Financial Officer to expend \$60,000.00 from the Water Fund No. 700011, contingent upon the Chief Financial Officer first furnishing a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. Authorizes the Comptroller to issue a check in the amount of \$60,000.00, made payable to the Briggs Law Corporation Trust Account.
