A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ALLOCATING \$11,500 TO FEEDING
SAN DIEGO FOR WAREHOUSE OPERATIONAL
EQUIPMENT PURSUANT TO COUNCIL POLICY 100-06,
“CITY COUNCIL FUNDING OF COMMUNITY PROJECTS,
PROGRAMS, AND SERVICES.”

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06,
titled “City Council Funding of Community Projects, Programs and Services” by San Diego
Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and
uniform requirements for awarding funds to and contracting with non-profit organizations and
public agencies for one-time community, social, environmental, cultural, or recreational needs
which serve a lawful public purpose; and

WHEREAS, the non-profit, Feeding San Diego (FSD), has requested funding for FY20
for warehouse operational equipment for their program supporting food distribution to needy
individuals throughout the City; and

WHEREAS, the requested funding will be used for a new sit-down forklift battery,
upgrades to safety lights for their forklift, and new electric pallet jackets; and

WHEREAS, FSD’s request for funding for the warehouse operational equipment will benefit the
public by insuring food distribution to needy individuals in the San Diego community; and

WHEREAS, it is the determination of the City Council that the above-described program
fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 6 and 7 recommend a total allocation of \$11,500 to
Feeding San Diego for the purposes set forth in this resolution, attributed as follows: Council

District 1 – \$5,000; Council District 6 – \$4,000; and Council District 7 –\$2,500; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.”

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and Feeding San Diego (Agreement) in an amount not to exceed \$11,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- **312933**.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1101110001 GL512059; \$4,000 from Council District 6: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1106110006 GL512059; and \$2,500 from Council District 7: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1107110007 GL512059, for a total of \$11,500, all to provide funds for the above-referenced Agreement, contingent upon the

Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
