A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$10,150 TO BIG BROTHERS BIG SISTERS OF SAN DIEGO COUNTY, INC. FOR ITS RECRUITMENT CAMPAIGN, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Big Brothers Big Sisters of San Diego County, Inc. has requested funding for its Recruitment Campaign; and

WHEREAS, the requested funding will be used to recruit additional mentors to its program, especially male big brothers who speak Spanish; and

WHEREAS, Big Brothers Big Sisters of San Diego County, Inc.'s request for funding for its Recruitment Campaign will benefit the public by supporting this program that demonstrates positive results in little brothers' and little sisters' school performance, better familial relationships, less likelihood of using illegal drugs, less likelihood of abusing alcohol, and less truancy; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 5, 6 and 7 recommend a total allocation of \$10,150 to Big Brothers Big Sisters of San Diego County, Inc. for its Recruitment Campaign for the purposes set forth in this resolution, allocated as follows: Council District 1- \$2,500; Council District 5 – \$2,150; Council District 6 – \$2,500; and Council District 7 –\$3,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.”

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and Big Brothers Big Sisters of San Diego County, Inc. for its Recruitment Campaign (Agreement) in an amount not to exceed \$10,150 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312934.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,500 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1101110001 GL 512059; \$2,150 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1105110005 GL 512059; \$2,500 from Council District 6: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1106110006 GL512059; and \$3,000 from Council District 7: Community Projects, Programs and Services budget Fund

No. 100000, Cost Center No. 1107110007 GL512059 for a total of \$10,150, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
