A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING APPLICATION TO THE INTEGRATED REGIONAL WATER MANAGEMENT GRANT PROGRAM FOR THE NORTH CITY PURE WATER FACILITY INFLUENT PUMP STATION AND CONVEYANCE PIPELINE PROJECT AND RELATED ACTIONS.

WHEREAS, the State of California Department of Water Resources (DWR) Integrated Regional Water Management (IRWM) Program supports the implementation of water management solutions on a regional scale and the program develops and implements multiple state voter approved propositions to fund water management projects that support the State's objectives to increase regional self-reliance and water supply; and

WHEREAS, the IRWM Program will provide funding for implementation of projects that meet the intent of Proposition 1, Chapter 7, to improve regional water security, and address climate change and drought preparedness; and

WHEREAS, the City of San Diego Public Utilities Department (PUD) seeks the award of funding through the IRWM Proposition 1 Round 1 funding cycle to assist with the construction of the North City Pure Water Facility Influent Pump Station and Conveyance Pipeline Project (Project), which meets the intent of the objectives for IRWM Program funding; and

WHEREAS, in May 2019, PUD staff applied to the San Diego IRWM Program to be included in the regional grant application for the State's IRWM Proposition 1 Round 1 funding and the San Diego IRWM Selection Workgroup convened and determined the City of San Diego's application to be eligible to progress in the selection process; and

WHEREAS, on August 2, 2019, San Diego IRWM notified PUD that the Project would be included in the Region's 2019 Proposition 1 Implementation Grant application to the State of California DWR, and a final determination of grant funding will be made by DWR; and

WHEREAS, the City of San Diego PUD proposes to apply for an amount up to \$1,477,600 in grant funds from the IRWM Proposition 1 Grant Program; NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee, is authorized to execute a financial assistance application to the State of California Department of Water Resources Integrated Regional Water Management (IRWM) Program and to take all necessary actions to secure funding in an amount not to exceed \$1,477,600 in IRWM grant funds for the construction of the Project.
- 2. That the Chief Financial Officer is authorized to accept, appropriate and expend an amount not to exceed \$1,477,600 from the Proposition 1 IRWM Grant Program, if grant funding is secured.
- 3. That the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP ALA00001, Pure Water Program (B-16140, North City Pure Water Facility Influent Pump Station and Pipeline) and to appropriate and expend an amount not to exceed \$1,477,600 (Fund 710001, State Grant Fund) Prop 1 IRWM Grant for the North City Pure Water Facility Influent Pump Station and Pipeline, contingent upon the receipt of a fully executed grant agreement.
- 4. That the Chief Financial Officer is authorized to decrease the Capital

 Improvements Program Budget in CIP ALA00001, Pure Water Program (B16140, North City

 Pure Water Facility Influent Pump Station and Pipeline) and to de-appropriate an amount not to

exceed \$1,477,600 (Fund 700010, Water Utility CIP) for the North City Pure Water Facility Influent Pump Station and Pipeline, contingent upon the receipt of a fully executed grant agreement.
