A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$20,200 TO THE INTERFAITH SHELTER NETWORK OF SAN DIEGO FOR ITS ROTATIONAL SHELTER PROGRAM TO HOUSING AND EL NIDO DV TRANSITIONAL HOUSING PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Interfaith Shelter Network of San Diego has requested funding for its Rotational Shelter Program to Housing and El Nido DV Transitional Housing Program (Programs); and

WHEREAS, the requested funding will be used for both Programs for office rental, telephone, internet, program insurance, accounting/bookkeeping, shelter equipment, printing, and computers/ software; and

WHEREAS, the Interfaith Shelter Network of San Diego's request for funding for its Rotational Shelter Program to Housing will benefit the public by providing needed case management services to stabilize each household it serves to prevent them from falling back into homelessness; and

WHEREAS, the Interfaith Shelter Network of San Diego's request for funding for its El Nido DV Transitional Housing Program will benefit the public by delivering transitional housing programs for adults and families affected by domestic violence; and,

WHEREAS, it is the determination of the City Council that the above-described Programs of the Interfaith Shelter Network of San Diego fit within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 2 and 7 recommend a total allocation of \$20,200 to the Interfaith Shelter Network of San Diego for the purposes set forth in this resolution, as follows: Council District 1 – \$5,000; Council District 2 - \$5,200 and Council District 7 –\$10,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and Interfaith Shelter Network of San Diego (Agreement) in an amount not to exceed \$20,200 for the Programs

described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- **312951** .

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1101110001 GL 512059; \$5,200 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1102110002 GL 512059; and \$10,000 from Council District 7: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1107110007 GL 512059, for a total of \$20,200, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
