DATE OF FINAL PASSAGE MAY 05 2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$18,000 TO SAN DIEGO LGBT PRIDE FOR THE 2019 SHE FEST AND SAN DIEGO PRIDE PARADE, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, San Diego LGBT Pride has requested funding for its She Fest and Pride Parade (Program); and

WHEREAS, the requested funding will be used for expenses associated with its Program, such as security and security equipment, traffic signage and barriers, trash disposal, clean-up supplies, event production, equipment rentals, staging, ASL interpreter fees, entertainment fees, marketing and staff time; and

WHEREAS, San Diego LGBT Pride's request for funding for its Program will benefit the public by highlighting and celebrating the LGBT community through fun, free educational events that promote diversity and inclusion, and foster civic pride through community engagement; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 2, 3 and 4 recommend a total allocation of \$18,000 to San Diego LGBT Pride for the purpose set forth in this resolution, as follows: Council District 1 – \$1,000; Council District 2 - \$10,000; Council District 3 - \$5,000; and Council District 4 –\$2,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.”

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: “Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued.”

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and San Diego LGBT Pride for its Program (Agreement) in an amount not to exceed \$18,000 for the program described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312952.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from Council District 1: Community Projects, Programs and

Services budget Fund No. 100000, Cost Center No. 1101110001 GL 512059; \$10,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1102110002 GL 512059; \$5,000 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1103110003 GL 512059; and \$2,000 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1104110004 GL 512059, for a total of \$18,000, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
