A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN PORTER FAMILY TRUST AND THE CITY OF SAN DIEGO.

WHEREAS, on December 8, 2018, PORTER FAMILY TRUST filed suit against the City of San Diego [City] alleging property damage arising from an incident that occurred on February 1, 2015. Plaintiffs brought suit in the Superior Court for the County of San Diego. The suit is entitled *Porter Family Trust v. City of San Diego, et al.*, Superior Court Case No. 37-2018-00061585-CU-OR-CTL [Litigation]; and

WHEREAS, in Closed Session on March 10, 2020, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays, none, and absent, none, approved the settlement; and

WHEREAS, the City Council in closed session on March 10, 2020, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

- 1. Authorizes the Mayor or his designee to pay the sum of \$147,811.57 from Fund 700011, Water Utility Operating Fund, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the water intrusion at Plaintiffs' property.
- Authorizes the Chief Financial Officer to expend \$147,811.57 from Fund 700011,
 Water Utility Operating Fund, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

 Authorizes the Department of Finance to issue a check in the amount of \$147,811.57, made payable to Borton Petrini, LLP Trust.
