DATE OF FINAL PASSAGE MAY 27 2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$15,000 TO PAVING GREAT FUTURES FOR WRAP AROUND SERVICE AND THE WELLNESS FESTIVAL, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Paving Great Futures has requested funding for its Wrap Around Service and Wellness Festival (Program); and

WHEREAS, the requested funding for its Wrap Around Service and Wellness Festival will be used for office and kitchen rental fees, permit fees, a Company van, marketing materials, computers, temporary street signs, T-shirt machines, recording equipment, uniforms, professional clothing, merchant services equipment and fees; and

WHEREAS, Paving Great Future's request for funding for its Wrap Around Service and its Wellness Festival will benefit the public by mobilizing disengaged and underrepresented people to learn about injustices and the tools that are needed to become leaders in the local community, and to provide opportunities to meet local leaders; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends a total allocation of \$15,000 to Paving Great Futures for the Wrap Around Service and the Wellness Festival for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and Paving Great Futures for its Programs (Agreement) in an amount not to exceed \$15,000 for the projects described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312969.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$15,000 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1104110004 GL 512059, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing

one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
