A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$12,000 TO FREE TO THRIVE FOR ITS SURVIVORS OF TRAFFICKING ESSENTIAL EMERGENCY RESOURCES PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Free to Thrive has requested funding for its Survivors Of Trafficking Essential Emergency Resources (S.T.E.E.R.) Program (Program); and

WHEREAS, the requested funding will be used for staff time to develop, market and conduct virtual trainings for the population it serves, staff time for resource navigators who assist human trafficking survivors in San Diego County access vital emergency resources and support, and staff time for survivor advocates who can provide comfort, support, and advocacy for survivors; and

WHEREAS, Free to Thrive's request for funding for its Program will benefit the public by assisting this vulnerable population with access to emergency services so that they do not end up homeless and food insecure, while the training will educate and increase awareness of the many issues that impact human trafficking survivors across the United States; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 3, 4, 6, and 7 recommend a total allocation of \$12,000 to Free to Thrive for the purposes set forth in this resolution, as follows: Council District 1 – \$2,500; Council District 3 - \$2,000; Council District 4 - \$2,500; Council District 6 - \$3,800 and Council District 7 –\$1,200; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and Free to Thrive for its Program (Program) in an amount not to exceed \$12,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312970.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,500 from Council District 1: Community Projects, Programs and
