A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$6,500 TO MEALS ON WHEELS SAN DIEGO COUNTY FOR ITS MARCH FOR MEALS 5K, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Meals for Wheels San Diego County has requested funding for its March for Meals 5K (Program); and

WHEREAS, the requested funding will be used for event supplies, promotional materials, and related personnel expenses; and

WHEREAS, Meals on Wheels San Diego County's request for funding for the March for Meals 5K will benefit the public by supporting Meals on Wheels' largest annual community event which is free to the public, and supporting Meals on Wheels' mission to address the health needs of seniors; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 2, 3 and 5 recommend a total allocation of \$6,500 to Meals on Wheels San Diego County for the purposes set forth in this resolution, as follows: Council District 2 – \$5,000; Council District 3 –\$2,000; and Council District 5 - \$1,500;

WHEREAS, Meals on Wheels' Program was postponed into FY21 due to the COVID-19 emergency and restrictions; and

WHEREAS, Meals on Wheels' Agreement has been amended to allow for reimbursement of expenses incurred in FY20, notwithstanding the fact that the Program will take place in FY21; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and Meals on Wheels San Diego County (Agreement) in an amount not to exceed \$6,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312979.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1102110002 GL 512059; \$2,000 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, Cost

Center No. 1103110003 GL 512059; and \$1,500 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1105110005 GL 512059, for a total of \$6,500, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
