A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$23,171 TO CITY HEIGHTS COMMUNITY DEVELOPMENT CORPORATION FOR THE CITY HEIGHTS VILLAGE FOR SENIORS, MID-CITY HOMELESS OUTREACH PROGRAM, AND THE RIDGEMVIEW COMMUNITY GARDEN, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, City Heights Community Development Corporation has requested funding for the City Heights Village for Seniors, the Mid-City Homeless Outreach Program, and the Ridgeview Community Garden (Programs); and

WHEREAS, the requested funding will be used to provide (1) the City Heights Village for Seniors with portable devices with videoconferencing capabilities and a Zoom subscription membership; (2) the Mid-City Homeless Outreach Program with funding for personnel support; and (3) the Ridgeview Community Garden with funding to offset the cost of the Conditional Use permit fee; and

WHEREAS, City Heights Community Development Corporation's request for funding for its Programs will benefit the public by (1) allowing local Senior citizens to virtually reach out

to other Senior citizens to combat social isolation and to support physical and emotional well-being; (2) providing support personnel to assist homeless individuals with accessing local services and developing consistent and trustworthy relationships; and (3) assuring the land for neighborhood beautification; and

WHEREAS, it is the determination of the City Council that the above-described programs fit within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 3 and 9 recommend a total allocation of \$23,171 to City Heights Community Development Corporation for the purposes set forth in this resolution, as follows: Council District 1 – \$2,500; Council District 3 - \$20,000 and Council District 9 –\$671; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and City Heights Community Development Corporation for its Programs (Agreement) in an amount not to

exceed \$23,171 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312983 .

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$2,500 from Council District 1: Community Projects, Programs and

Services budget Fund No. 100000, Cost Center No. 1101110001 GL 512059; \$20,000 from

Council District 3: Community Projects, Programs and Services budget Fund No. 100000, Cost

Center No. 1103110003 GL 512059; and \$671 from Council District 9: Community Projects,

Programs and Services budget Fund No. 100000, Cost Center No. 1109110009 GL 512059, for a

total of \$23,171, all to provide funds for the above-referenced Agreement, contingent upon the

Chief Financial Officer first furnishing one or more certificates certifying that the funds

necessary for expenditure are, or will be, on deposit with the City Treasurer.
