A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$14,500 TO THE SAN DIEGO LIBRARY FOUNDATION TO UPDATE THE 2002 21<sup>ST</sup> CENTURY PLAN, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego Library Foundation has requested funding for an update of the 2002 21st Century Library Plan (Service); and

WHEREAS, the requested funding will be used for a library consultant, "Group 4 Architecture, Research, +Planning, Inc."; and

WHEREAS, the San Diego Library Foundation's request for funding for the Service will benefit the public by providing analysis of the needs of the library system and of how the evolution of the library system over the next decade will best serve the community; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 2 and 5 recommend a total allocation of \$14,500 to the San Diego Library Foundation for the purposes set forth in this resolution, as follows: Council

District 1 – \$5,000; Council District 2 - \$8,000 and Council District 5 –\$1,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2020 City Council Allocations Agreement between the City of San Diego and the San Diego Library Foundation for its Service (Agreement) in an amount not to exceed \$14,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312984.

an amount not to exceed \$5,000 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1101110001 GL 512059; \$8,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1102110002 GL 512059; and \$1,500 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1105110005 GL 512059, for a total of \$14,500, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
