DATE OF FINAL PASSAGE MAY 27 2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO HOME START FOR THE MIRACLE ON 34<sup>TH</sup> STREET PROJECT AND TO JERABEK ELEMENTARY FAMILY FACULTY ORGANIZATION FOR MOVIE NIGHT, PURSUANT TO COUNCIL POLICY 100-06, TITLED "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City received and evaluated two applications for Community Projects, Programs and Services (CPPS) funding for the following purposes:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Home Start	Miracle on 34 <sup>th</sup> Street Project	Provide the homeless youth population with affordable housing with wraparound services to achieve long term self-sufficiency and to reduce the incidence of homelessness.

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Jerabek Elementary Family Faculty Organization	Movie Night	Provide family/community oriented activity for a safe and fun activity free of charge (this activity took place before the stay at home order was in place).

WHEREAS, it is the determination of the City Council that the above-described programs are consistent with the parameters outlined in Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$9,000 to Home Start for affordable housing and wraparound supportive services port as set forth in this resolution; and

WHEREAS, Council District 5 recommends an allocation of \$1,500 to Jerabek Elementary Family Faculty Organization for technological optimization and configuration as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies, or materials which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, CPPS FY 2020 City Council Allocation Agreements between the City of San Diego and (1) Home Start in an amount not to exceed \$9,000 and (2) Jerabek Elementary Family Faculty Organization in an amount not to exceed

\$1,500, under terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR- 312998-1 for Home Start and Document No. RR- 312998-2 for Jerabek Elementary Family Faculty Organization.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend a total amount not to exceed \$10,500 from the Council District 5's CPPS budget Fund No. 10000, Cost Center 1105110005 GL512059, to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
