DATE OF FINAL PASSAGE MAY 19 2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING EXPENDITURES IN THE RECYCLING ENTERPRISE FUND TO FUND THE CURBSIDE RECYLING PROGRAM.

WHEREAS, the California Integrated Waste Management Act of 1989 (AB 939) was enacted to reduce, recycle, and reuse solid waste; and

WHEREAS, pursuant to AB 939 and Division 30 of the California Public Resources Code, the City is required to prepare, adopt and implement an Integrated Waste Management Plan (Plan); and

WHEREAS, pursuant to San Diego Municipal Code section 66.0135, the Recycling Enterprise Fund shall be used to cover the costs associated with preparing, adopting and implementing the Plan; and

WHEREAS, as part of the Plan, the City provides a comprehensive residential curbside recycling program to divert household recyclables from the City's waste stream; and

WHEREAS, in September 2019, the City entered into new recyclable materials processing contracts with two contractors to process, transport, and market the recyclable materials collected in the City's curbside recycling program; and

WHEREAS, due to new costs associated with the curbside recycling processing contracts and changes in the international recycling markets, an expenditure appropriation of \$2,000,000 is needed in the Recycling Enterprise Fund to fully fund the curbside recycling program in Fiscal Year 2020; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer or designee is authorized to increase expenditure appropriations by \$2,000,000 for Fiscal Year 2020 in the Recycling Enterprise Fund to pay the costs incurred by the City in preparing, adopting and implementing the Plan, including the curbside recycling program.


