A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO SAN DIEGO ART INSTITUTE, SAN DIEGO INTERNATIONAL SISTER CITIES ASSOCIATION, SAN DIEGO OPERA ASSOCIATION, ST. VINCENT DE PAUL VILLAGE, INC., AND YOUNG AUDIENCES OF SAN DIEGO DBA ARTS FOR LEARNING, PURSUANT TO COUNCIL POLICY 100-06, TITLED "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City received and evaluated four applications for Community Projects,

Programs and Services (CPPS) funding for the following purposes:

San Diego Art Institute	Forging Territories	Funds will be used for artists, a curator, equipment, and marketing costs. The public will benefit from the support of a program that provides free discussions and events focused on the Queer Afro and Latinx communities.

ORGANIZATION	PROGRAM/ACTIVITY	USE OF FUNDS/PUBLIC BENEFIT
San Diego International Sister Cities Association	Connect World – Multicultural After School Program	Funds will be used for video equipment, uniforms, software, strategy board games and other recreational equipment, CPR training, insurance, and other related supplies. The public benefits from the Program by exposing youth to a global learning approach and by positively contributing to ethnic diversity.
San Diego Opera Association	Capital Equipment	Funds will be used for new firewalls for hardware and software. The public will benefit by the support to an organization to allow it to continue to present communities with access to arts opportunities.
St. Vincent de Paul Village, Inc.	Joan Kroc Center Drapes	Funds will be used to purchase drapes. The benefit to the public is that the shelter environment will be more beautiful for persons experiencing homelessness while they are on the road to self-sufficiency.

WHEREAS, it is the determination of the City Council that the above-described programs are consistent with the parameters outlined in Council Policy 100-06; and

WHEREAS, Council District 2 recommends an allocation of \$2,000 to San Diego Art

Institute for support as set forth in this resolution; and

WHEREAS, Council District 2 further recommends an allocation of \$2,500 to San Diego International Sister Cities Association for support as set forth in this resolution; and

WHEREAS, Council District 2 further recommends an allocation of \$4,000 to San Diego Opera Association for support as set forth in this resolution; and

WHEREAS, Council District 2 further recommends an allocation of \$4,000 to St. Vincent de Paul Village, Inc. for support as set forth in this resolution; and

WHEREAS, Council District 2 further recommends an allocation of \$5,000 to Young Audiences of San Diego dba Arts for Learning for support as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies, or materials which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, CPPS FY 2020 City Council Allocation Agreements between the City of San Diego and (1) San Diego Art Institute in an amount not to exceed \$2,000, (2) San Diego International Sister Cities Association in an amount not to exceed

\$2,500, (3) San Diego Opera Association in an amount not-to-exceed \$4,000, (4) St. Vincent de Paul Village, Inc. in an amount not to exceed \$4,000, and (5) Young Audiences of San Diego dba Arts for Learning in an amount not to exceed \$5,000, under terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR-313015 for San Diego Art Institute; Document No. RR-313015 for San Diego International Sister Cities Association; Document No. RR-313015-3 for San Diego Opera Association; Document No. RR-313015-5 for St. Vincent de Paul Village, Inc; and Document No. RR-313015-5 for Young Audiences of San Diego dba Arts for Learning.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend a total amount not to exceed \$17,500 from the CPPS budget Fund No. 10000, Cost Center 1102110002 GL512059, to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
