A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR, ACCEPT, APPROPRIATE, AND EXPEND \$1,217,682.00 IN GRANT FUNDING, AND ANY ADDITIONAL FUNDING AVAILABLE AND SECURED FROM THE FEDERAL CORONAVIRUS EMERGENCY SUPPLEMENTAL GRANT PROGRAM.

WHEREAS, a novel coronavirus (coronavirus) causes infectious disease and was first detected in December 2019; and

WHEREAS, coronavirus symptoms include fever, cough, and shortness of breath, and those who have been afflicted have experienced anything from mild illness to death; and

WHEREAS, the Centers for Disease Control and Prevention considers coronavirus to be a very serious public health threat and the World Health Organization declared the coronavirus outbreak to be a worldwide pandemic; and

WHEREAS, on February 19, 2020, the County Board of Supervisors ratified a declaration of local health emergency related to coronavirus; and

WHEREAS, on March 4, 2020, Governor Gavin Newsom proclaimed a State of Emergency in California as a result of the threat of coronavirus; and

WHEREAS, on March 12, 2020, Mayor Kevin Faulconer proclaimed the existence of a local emergency in the City of San Diego (City) as a result of coronavirus, which was ratified by the Council of the City of San Diego (Council) on March 17, 2020; and

WHEREAS, the Governor of California, the Mayor of San Diego, and the San Diego
County Public Health Officer have issued Executive Orders and Public Health Orders designed
to protect public health and safety; and

WHEREAS, the Coronavirus Emergency Supplemental Funding (CESF) Program is authorized by Division B of H.R. 748, Pub. L. No. 116-136 (Emergency Appropriations for Coronavirus Health Response and Agency Operations) under 28 U.S.C. section 530C, to assist eligible states, local units of government, and tribes in preventing, preparing for, and responding to the coronavirus and will be implemented and administered by the U.S. Department of Justice; and

WHEREAS, the FY 2020 grant funding allocation for the CESF Program for state and local law enforcement assistance is allocated by state and the eligible allocation for California is \$58,518,568; and

WHEREAS, there is no requirement for matching or cost sharing funds under the CESF Program; however, funds must be used to increase the amounts of such funds that would, in the absence of federal funds, be made available. Funds may not be used to supplant state or local funds; and

WHEREAS, the CESF Program allows eligible states and units of local government to draw down funds either in advance or on a reimbursable basis. Expenditures will be initially sourced from fund 600000 (Grant Fund – Federal), and then reimbursed from the federal FY 2020 Coronavirus Emergency Supplemental Funding Program; and

WHEREAS, allowable projects and purchases include overtime, law enforcement and medical personal protective equipment, hiring, supplies, training, travel expenses particularly related to the distribution of resources to the most impacted areas, and addressing the medical needs of inmates in state, local, and tribal prisons, jails, and detention centers; and

WHEREAS, the grant is available for a period of performance of two years beginning January 20, 2020; and

WHEREAS, the San Diego Police Department is requesting authorization to apply, accept, appropriate and expend \$1,217,682.00 in grant funding from the CESF Program to support the increased staffing levels of the San Diego Police Department on the basis of eligible overtime due to the coronavirus pandemic. This increase in staffing is necessary in order to implement the state, county and local public health orders and promote the health and safety of the citizens of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, for and on behalf of the City, is authorized to apply and accept \$1,217,682.00 and any additional grant funding authorized by the U.S. Department of Justice, Office of Justice Programs Bureau of Justice Assistance, including any amendments, extensions, or renewals for the period January 20, 2020 through January 19, 2022, provided funding is secured and made available by the U.S. Department of Justice, Office of Justice Programs Bureau of Justice Assistance, for the purpose of implementing the Coronavirus Emergency Supplemental Funding (CESF) Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend \$1,217,682.00 and any additional grant funding authorized by the U.S. Department of Justice, Office of Justice Programs Bureau of Justice Assistance, including any amendments, extensions, or renewals for the period January 20, 2020 through January 19, 2022, provided funding is secured and made available by the U.S. Department of Justice, Office of Justice Programs Bureau of Justice Assistance, for the purpose of implementing the Coronavirus Emergency Supplemental Funding (CESF) Program.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to enter into all agreements and certifications necessary for the purpose of implementing the Coronavirus Emergency Supplemental Funding (CESF) Program.
