A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO ASSISTANCE LEAGUE OF GREATER SAN DIEGO, CALIFORNIA WESTERN SCHOOL OF LAW, CATHOLIC CHARITIES DIOCESE OF SAN DIEGO, FERN STREET COMMUNITY ARTS, INC., AND MAMA'S KITCHEN, PURSUANT TO COUNCIL POLICY 100-06, TITLED "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City received and evaluated five applications for Community Projects, Programs and Services (CPPS) funding for the following purposes:

ORGANIZATION	PROGRAM/ACTIVITY	USE OF FUNDS/PUBLIC BENEFIT
Assistance League of Greater San Diego	Trauma Clothing Program	Funds will be used for clothing items for hospital patients who do not have are discharged without having adequate clothing upon discharge. The public will benefit by ensuring that persons who are discharged from the hospital have essential clothing that they need.

ORGANIZATION	PROGRAM/ACTIVITY	USE OF FUNDS/PUBLIC BENEFIT
California Western School of Law	Community Law Project	Funds will be used for salary costs for the Project staff to provide housing related assistance and information. The public will benefit by supporting a Project that addresses housing issues by providing low-income tenants with legal information they need to maintain adequate housing and avoid homelessness.
Catholic Charities Diocese of San Diego	Rachel's Women's Center	Funds will be used for supplies for the Center. The public will benefit by supporting a Program that provides homeless/low income women with the basic amenities, such as restroom facilities, showers, clothing, laundry facilities, meals and a mailing address.
Fern Street Community Arts, Inc.	Circus Equipment	Funds will be used towards the purchase of a 15' box truck and a 12-14' dual axel covered trailer to transport and store circus equipment. The public will benefit by assisting the organization to organize and store equipment for on-going use, thereby increasing the organization's production capacity.

ORGANIZATION	PROGRAM/ACTIVITY	USE OF FUNDS/PUBLIC BENEFIT
Mama's Kitchen	Meal Delivery and Pantry Equipment	Funds will be used towards the purchase of pushcarts to transport food and the purchase of delivery bags, speed racks, and small kitchen ward for meal preparation, and new shelving for the food pantry. The public will benefit by supporting an organization that helps San Diego residents avoid hunger and achieve better health outcomes.

WHEREAS, it is the determination of the City Council that the above-described programs are consistent with the parameters outlined in Council Policy 100-06; and

WHEREAS, Council District 3 recommends an allocation of \$2,500 to Assistance League of Greater San Diego for support as set forth in this resolution; and

WHEREAS, Council District 3 further recommends an allocation of \$10,000 to California Western School of Law for support as set forth in this resolution; and

WHEREAS, Council District 3 further recommends an allocation of \$3,000 to Catholic Diocese of San Diego for support as set forth in this resolution; and

WHEREAS, Council District 3 further recommends an allocation of \$2,500 to Fern Street Community Arts, Inc. for support as set forth in this resolution; and

WHEREAS, Council District 3 further recommends an allocation of \$3,000 to Mama's Kitchen for support as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies, or materials which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, CPPS FY 2020 City Council Allocation Agreements between the City of San Diego and (1) Assistance League of Greater San Diego in an amount not to exceed \$2,500, (2) California Western School of Law in an amount not to exceed \$10,000, (3) Catholic Diocese of San Diego in an amount not-to-exceed \$3,000, (4) Fern Street Community Arts, Inc. in an amount not to exceed \$2,500, and (5) Mama's Kitchen in an amount not to exceed \$3,000, under terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR-313037.1 for Assistance League of Greater San Diego; Document No. RR-313037.2 for California Western School of Law; Document No. RR-313037.3 for Catholic Diocese of San Diego; Document No. RR-313037.4 for Fern Street Community Arts, Inc.; and Document No. RR-313037.5 for Mama's Kitchen.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend a total amount not to exceed \$21,000 from the CPPS budget Fund No. 10000, Cost Center 1103110003 GL512059, to provide funds for the above-referenced Agreements, contingent upon

the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
