A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SECOND AMENDMENT TO THE COOPERATIVE PROCUREMENT CONTRACT BETWEEN THE CITY OF SAN DIEGO AND AT&T CORPORATION FOR THE PROVISION OF MULTI-PROTOCOL LABEL SWITCHING (MPLS) ASSETS & SERVICES.

WHEREAS, the State of California's Department of Technology Services procures discounted telecommunications services known as CalNet through volume purchases on behalf of itself and other state and local government agencies, and the State completed its most recent CalNet Request for Proposal (RFP) process and awarded the CalNet3 contract to AT&T Corporation (AT&T) on November 15, 2013 (Agency Agreement); and

WHEREAS, as provided for in Section 22.3208 of the San Diego Municipal Code, the Purchasing Agent for the City of San Diego (City) certified in writing that use of the CALNET cooperative procurement contract is in the City's best interests, to the City's economic advantage, and the agency's contract was awarded using a process that complies with the City's policies, rules, and regulations; and

WHEREAS, effective as of August 19, 2016, the City entered into a contract with AT&T for a term extending through June 30, 2018, plus two additional one-year options to use the CalNet3 contract to purchase a comprehensive array of telecommunications services, including local and long-distance services, voicemail, call routing services, and internet services (Contract); and

WHEREAS, the City entered into the First Amendment to the Contract to increase the Contract's not-to-exceed amount, effective as of December 20, 2017; and

WHEREAS, effective as of October 1, 2019, the State of California extended the Agency Agreement through December 31, 2021; and

WHEREAS, the City now wishes to enter into the Second Amendment to the Contract to increase the Contract's not-to-exceed amount by \$4,501,803 from \$16,429,000 to a total of \$20,930,803 during the full term of the Contract, and to extend the term of the Contract through August 18, 2021; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to approve the resolution to execute, for and on behalf of the City, the Second Amendment to the CALNET3 Cooperative Procurement Contract between the City of San Diego and AT&T Corporation for the Provision of Multi-protocol Label Switching (MPLS) Assets and Services, to extend the term of the Contract through August 18, 2021 and to increase the not-to-exceed amount of the Contract by \$4,501,803 from \$16,429,000 to a total of \$20,930,803, pursuant to the terms and conditions contained in the Second Amendment to the original Contract on file with the Office of the City Clerk as Document No. RR-313048

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$20,930,803 over the full term of the Contract, including any options to renew, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
