A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING MEMBERSHIP RENEWAL AND CONTINUED PARTICIPATION IN PUBLIC RISK INNOVATION, SOLUTIONS AND MANAGEMENT (PRISM).

WHEREAS, the City of San Diego (City) is a 25-year member of Public Risk
Innovation, Solutions and Management (PRISM), formerly known as the California State
Association of Counties-Excess Insurance Authority (CSAC-EIA); and

WHEREAS, PRISM is a member-directed risk sharing pool of public agencies committed to providing risk coverage programs and risk management services, facilitating joint purchase of Property/Earthquake and Excess Liability insurance coverage with the combined purchasing power of 55 counties and 287 non-county public entities; and

WHEREAS, with its continuing membership in PRISM, the City has been able to purchase comprehensive Property and General Liability insurance at favorable market rates, as well as other specialty lines of coverage including Airports, Aircraft, Pollution Liability, Crime Bond/Employee Dishonesty, and Cyber Liability; and

WHEREAS, the City's membership in PRISM also enables it to access additional risk management and loss control partner program services at reduced or no cost; and

WHEREAS, funding for the insurance premiums is budgeted through the annual budget process in the General, Public Liability, and Enterprise Funds as a non-discretionary line item in the appropriate department and fund; and

WHEREAS, the budget for the non-discretionary insurance may vary from year to year due to changing property values, special requirements, liability limits, modifications to City assets, risk exposure and overall market conditions; and

WHEREAS, funding for risk management services or programs is budgeted through the annual budget process in the City department needing the service; and

WHEREAS, the City's continuing membership in PRISM is contingent upon annual approval of Risk Management's budget; and

WHEREAS, the City's membership in PRISM was last approved by the San Diego City Council on June 9, 2015 (San Diego Resolution R-309786), whereby it was continued through June 30, 2020; and

WHEREAS, the City desires to continue its membership in PRISM; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to continue the City's membership in PRISM for the period beginning July 1, 2020 (FY21) through June 30, 2025 (FY26).

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to renew the City's insurance coverages annually as appropriated by City Council in the annual budget for the period of July 1, 2020 (FY21) through June 30, 2025 (FY26).

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to access other cost-effective insurance solutions and risk management services annually as appropriated in the annual budget for the period of July 1, 2020 (FY21) through June 30, 2025 (FY26).
