A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ENTER INTO AN AGREEMENT WITH SAN DIEGO SPORTS MEDICINE TO PROVIDE HEALTH SERVICES TO THE SAN DIEGO FIRE-RESCUE DEPARTMENT

WHEREAS, in July 2015, the City Council approved Resolution R-309820 authorizing the City to enter into a five-year agreement with San Diego Sports Medicine and Family Health Center (SDSM) for the delivery of health services through the City of San Diego Fire-Rescue Wellness Program (Wellness Program); and

WHEREAS, the City released a request for proposal for the Wellness Program in the Spring of 2020; and

WHEREAS, SDSM has been selected to again provide the San Diego Fire-Rescue's Wellness Program; and

WHEREAS, the Wellness Program, instituted in 2004, has revealed incredible success and resulted in a fitter and healthier Fire-Rescue workforce, with lower injury rates and countless lives saved; and

WHEREAS, the services provided by SDSM will include all components of the Wellness Fitness Initiative designed by the International Association of Fire Chiefs and the International Association of Firefighters; and

WHEREAS, the services to be provided by SDSM include annual medical and fitness evaluations, ongoing education, lifestyle and behavioral programs, injury prevention and data collection; and

WHEREAS, as part of the Fire-Rescue Wellness Program, SDSM will also provide services related to a new Injury Rehabilitation and Prevention Program (IRPP), which will work to increase the overall health of the City's first responders, increase the resiliency to injuries through aggressive and proven techniques, and provide faster rehabilitation for minor injuries; and

WHEREAS, it is expected that the IRPP will decrease overtime expenditures due to vacancies resulting from injuries and increase the number of Fire-Rescue first responders available to serve the public; and

WHEREAS, it is the goal of the IRPP to produce a workforce with increased individual performance and productivity during emergency operations; and

WHEREAS, the compensation to SDSM under the first year of the Agreement is a not to exceed amount of \$2,100,000 for Fiscal Year 2021; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to approve and execute, for and on behalf of the City, an agreement with San Diego Sports Medicine and Family Health Center for provision of the Fire-Rescue Department Wellness Program, for a term of three years, and at the sole discretion of the City, the option to extend the agreement for two (2) additional one (1) year periods, in an amount not to exceed \$11,500,000 over the five-year term of the Agreement, pursuant to the terms and conditions set forth in the Agreement, on file with the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend funds in an amount not to exceed \$2,100,000 in Fiscal Year 2021, and \$9,400,000 from the General Fund for Fiscal Years 2022-2025, contingent upon adoption of the Annual

Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
