A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING A CONTRACT WITH  
HILL BROTHERS CHEMICAL CO. (BID NO. 10089621-20-V)  
TO PROVIDE AMMONIUM HYDROXIDE FOR  
WATER TREATMENT PLANTS.

WHEREAS, the Public Utilities Department, Water System Operations Division, utilizes approximately 1,460,000 gallons of Ammonium Hydroxide per year at its water filtration plants to prolong the effectiveness of disinfecting of Chlorine when added to drinking water; and

WHEREAS, an Invitation to Bid (ITB), BID No. 10089621-20-V for a 5-year contract to furnish the City of San Diego with Ammonium Hydroxide was issued by the Purchasing and Contracting Department on November 7, 2019, and awarded to Hill Brothers Chemical Co. as the low, responsive and responsible bidder (Contract); and

WHEREAS, an award of this Contract in the amount not to exceed \$4,517,756, would allow the anticipated expenditure of \$817,600 for Fiscal Year 2020 and \$3,700,156 for the remaining four Fiscal Years through FY 2024; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Mayor, or his designee, is authorized and empowered to execute, for and on behalf of the City, the Contract with Hill Brothers Chemical Co. to provide Ammonium Hydroxide for water filtration plants within the Public Utilities Department for the treatment and disinfection of water, as-required, in an amount not to exceed \$4,517,756 for the duration of five (5) years, under the terms and conditions set forth in the Contract on file in the Office of the City Clerk as Document No. RR313073, contingent upon the Chief Financial Officer first

furnishing one or more certificates demonstrating that the funds for this expenditure are, or will be, on deposit with the City Treasurer; and

2. That the Chief Financial Officer is authorized and empowered to expend a cumulative amount not to exceed \$4,517,756, from Water Utility Operating Fund 700011, over the term of the Contract for the purpose of funding the Hill Brothers Chemical Co. Contract, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates demonstrating that the funds for this expenditure are, or will be, on deposit in the City Treasury.


