A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF AN AS-NEEDED AGREEMENT WITH OWEN GROUP FOR CONSULTANT SERVICES.

WHEREAS, the City of San Diego (City) issued a Request for Proposal (RFP) to retain the services of a qualified consultant to provide civil engineering services on an as-needed basis; and

WHEREAS, Owen Group submitted a bid in response to the City's RFP, and was selected following a competitive selection process to provide the City with civil engineering services; and

WHEREAS, the terms of the Agreement between the City and Owen Group are expressed in the agreement between the City and Owen Group and the attachments incorporated into the agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with Owen Group to provide as-needed civil engineering services in an amount not to exceed \$1,000,000 over thirty-six months with an optional twelve months extension under the terms and conditions set forth in the agreement, on file in the Office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$1,000,000 over thirty-six months with an optional twelve months extension for the purpose of funding the as-needed agreement with Owen Group, contingent upon the Chief Financial Officer first furnishing one or more
