DATE OF FINAL PASSAGE JUN 18 2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE AN AS-NEEDED SERVICE AGREEMENT FOR BRUSH MANAGEMENT SERVICES FOR CITY OPEN SPACE AND PARKS, AND WITHIN TRANSPORTATION AND STORMWATER STREETS RIGHT OF WAY.

WHEREAS, a Request for Proposal for brush management services on an as-needed basis for City open space and parks, and within Transportation and Stormwater streets right of way was issued on November 20, 2019, and three companies submitted proposals; and

WHEREAS, Aztec Landscaping, Inc. had the lowest qualified bid; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego (City), that the Mayor or his designee is authorized and directed to execute, for and on behalf of the City, the agreement resulting from the Request for Proposal Bid/Contract, Addendum A (RFP 10089607-20-G) to furnish the City of San Diego with Brush Management Services for Open Space and Park Property Managed by the Parks and Recreation Department, and Streets Right-of-Way Property Managed by the Transportation and Stormwater Department with Aztec Landscaping, Inc. (As-Needed Services Contract), on file in the Office of the City Clerk as Document No.

RR-313095, the terms and conditions set forth in the As-Needed Services Contract for as-needed brush management services having an initial term of one year, with four options to renew of one year each option, provided that the Chief Financial Officer first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer, for a total contract term of five years.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$15,000,000 over five years (\$2,650,000 in Fiscal Year 2021 from Fund No. 100000, Open Space Brush Management Program, and \$250,000 in Fiscal Year 2021 from Fund No. 100000, TSW, for a total of \$2,900,000), for the purpose of funding the As-Needed Services Contract, contingent upon adoption of the brush management budget(s) and the Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

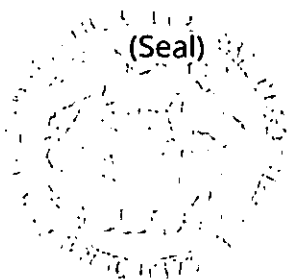
