WHEREAS, in closed session on April 7, 2020, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays, none, Absent, none; approved the Settlement for an amount consistent with the amounts set forth below; NOW, THEREFORE,

WHEREAS, the City Council in closed session on April 7, 2019, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$497,500.00 from Water Fund No. 700011, cost center 2000211101, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the complaint filed by Plaintiff Scripps Health dba Scripps Green Hospital.
