WHEREAS, in closed session on May 12, 2020, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, none; Absent, none, approved settlement of Plaintiff's personal injury claim in the sum of \$600,000.00; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

- 1. The Mayor or his designee to pay the sum of \$600,000.00 from Public Liability

 Treasurer.
