A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT OF JULIO
CESAR ORTIZ AND CITY OF SAN DIEGO

WHEREAS, on June 5, 2018, Plaintiff Julio Cesar Ortiz filed suit against the City of San Diego, alleging personal injuries from an automobile accident that occurred on July 25, 2017, entitled *Julio Cesar Ortiz v City of San Diego, et al.* San Diego Superior Court Case No. 37-2018-00027484-CU-PO-CTL; and

WHEREAS, in closed session on May 12, 2020, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, none; Absent, none, approved settlement of Plaintiff's personal injury claim in the sum of \$600,000.00; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. The Mayor or his designee to pay the sum of \$600,000.00 from Public Liability Fund No. 720045, in settlement of every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury complaint filed by Plaintiff Julio Cesar Ortiz.

2. The Chief Financial Officer to expend \$600,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. The Department of Finance to issue a check in the amount of \$600,000.00 made payable to Gomez Trial Attorneys Trust Account F.B.O Julio Ortiz.



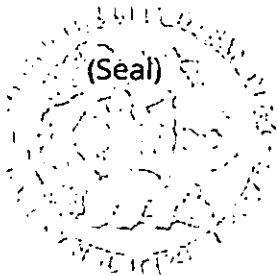
