A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THIRD QUARTER REVISIONS TO THE FISCAL YEAR 2020 BUDGET OF THE CITY OF SAN DIEGO.

WHEREAS, on June 18, 2019, the Mayor approved Resolution No. R-312506, approving the City's Fiscal Year 2020 Budget (2020 Budget); and

WHEREAS, on June 25, 2019, the San Diego City Council (Council) adopted Ordinance No. O-21091, entitled "An Ordinance Adopting the Annual Budget for Fiscal Year 2020 and Appropriating the Necessary Money to Operate the City of San Diego for Fiscal Year 2020."

(Appropriation Ordinance); and

WHEREAS, on December 12, 2019, the Mayor approved Resolution No. R-312751, approving revisions to the Fiscal Year 2020 Budget as presented in the Fiscal Year 2020 First Quarter Budget Monitoring Report.

WHEREAS, on March 13, 2020, the Mayor approved Resolution No. R-312871, approving the Mid-Year Revisions to the 2020 Budget; and

WHEREAS, the Mayor has now proposed to revise the 2020 Budget as presented in the Fiscal Year 2020 Third Quarter Budget Monitoring Report (Third Quarter Report) and the Third Quarter Report was presented to the Council, sitting as the Budget Review Committee, on May 21, 2020; and

WHEREAS, section 16 of the Appropriation Ordinance authorizes the Chief Financial Officer to modify appropriations upon adopted Council resolution, provided funding is available for such action and in accordance with funding source guidelines and applicable grant agreements; and

WHEREAS, San Diego Charter (Charter) section 73 permits the Council, upon the written recommendation of the Mayor, to transfer all or part of an unencumbered balance of an appropriation to a purpose or object for which the appropriation for the current year has proved insufficient; and

WHEREAS, a public hearing to consider the proposed budget revisions has been held in accordance with Charter section 69; and

WHEREAS, the Council desires to approve the proposed appropriation changes as described below and in accordance with the Third Quarter Report; NOW, THEREFORE;

BE IT RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to revise the Fiscal Year 2020 Budget, as detailed in the Third Quarter Report, as follows:

- Adjust General Fund (100000) revenue and expenditure appropriations as follows:
  - a. Increase expenditure appropriations by up to \$3,990,000 in the Police
     Department (1914).
  - Increase expenditure appropriations by up to \$3,130,000 in the
     Neighborhood Services Department (1715).
  - c. Increase expenditure appropriations by up to \$2,220,000 in the Fire-Rescue Department (1912).
  - d. Increase expenditure appropriations by up to \$195,000 in the Personnel
     Department (1212).
  - e. Decrease expenditure appropriations by up to \$6,955,000 in Citywide

    Program Expenditures (9912).

f. Decrease expenditure appropriations by up to \$1,550,00 in Parks and

Recreation Department (1714).

Decrease expenditure appropriations by up to \$1,030,000 in g.

Transportation & Storm Water Department (2116).

2. Non-General Funds:

> a. Increase the CARES Grant Funds (200810) expenditure and revenue

appropriations by up to \$88,413,606.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer

appropriations between General Fund (100000) departments as necessary where the net transfer

does not result in an increase to either department's current budget.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer

appropriations among General Fund (100000) departments as necessary at fiscal year close to

match actual activity.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to adjust

appropriations for unforeseen events in order to close Fiscal Year 2020 with departments and

funds in balance.
