A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SAN DIEGO AND THE SAN DIEGO HOUSING COMMISSION FOR THE PROVISION OF THE SAFE PARKING PROGRAM.

WHEREAS, the San Diego Housing Commission (Housing Commission) administers the agreements for the City of San Diego (City)'s Homeless Shelters and Services Programs based on a Memorandum of Understanding between the Housing Commission and the City that first took effect on July 1, 2010; and

WHEREAS, the City has been administering operation of three safe parking lot sites to serve individuals and families experiencing homelessness since October 2017; and

WHEREAS, the City and Housing Commission now desire to transfer administration of the program to the Housing Commission and to enter into a new Memorandum of Understanding Between the City of San Diego and the San Diego Housing Commission for the Provision of the Safe Parking Program to identify the roles and responsibilities of the parties related to oversight and administration of the safe parking program for a one year term, with two one-year options to renew; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Mayor, or designee, is authorized and directed to sign the Memorandum of Understanding Between the City of San Diego and the San Diego Housing Commission for the Provision of the Safe Parking Program (MOU), a copy of which is on file with the City Clerk as

2. The effectiveness of this Resolution is contingent upon passage of a Housing Authority resolution approving the Housing Commission's signature of the MOU, which is being considered by the Housing Authority concurrently with this Resolution.

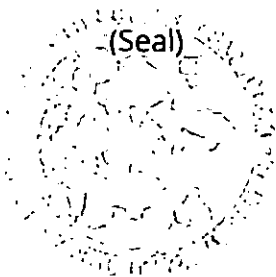
