A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING EXECUTION OF A
MEMORANDUM OF UNDERSTANDING BETWEEN THE
CITY OF SAN DIEGO AND THE SAN DIEGO HOUSING
COMMISSION FOR THE PROVISION OF TEMPORARY
BRIDGE SHELTERS.

WHEREAS, the San Diego Housing Commission (Housing Commission) administers the agreements for the City of San Diego (City)'s Homeless Shelters and Services Programs based on a Memorandum of Understanding between the Housing Commission and the City that first took effect on July 1, 2010; and

WHEREAS, in November 2017, the City and Housing Commission executed a separate Memorandum of Understanding for the Provision of Temporary Bridge Shelters, which was approved by the San Diego City Council and the Housing Authority of the City of San Diego, and which expires on June 30, 2020; and

WHEREAS, the City and Housing Commission desire to enter into a new Memorandum of Understanding for the Provision of Temporary Bridge Shelters to identify the roles and responsibilities of the parties related to oversight and administration of the City's temporary bridge shelters for a one year term, with two one-year options to renew; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Mayor, or designee, is authorized and directed to sign the Memorandum of Understanding Between the City of San Diego and the San Diego Housing Commission for the Provision of Temporary Bridge Shelters (MOU), a copy of which is on file with the City Clerk as Document No. RR- 313111

2. The effectiveness of this Resolution is contingent upon passage of a Housing Authority resolution approving the Housing Commission's signature of the MOU, which is being considered by the Housing Authority concurrently with this Resolution.



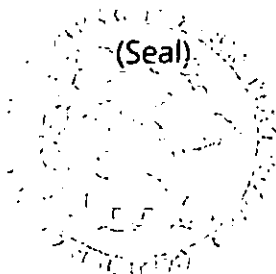
