DATE OF FINAL PASSAGE JUL 10 2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO DECLARING A CONTINUED LOCAL  
EMERGENCY REGARDING THE CORONAVIRUS  
COVID-19 OUTBREAK.

WHEREAS, on March 4, 2020, the Governor of California declared a state of emergency as a result of the threat of the novel coronavirus, COVID-19; and

WHEREAS, on March 12, 2020, the Mayor of the City of San Diego (Mayor) proclaimed the existence of a local emergency related to the COVID-19 threat, which was ratified by the San Diego City Council on March 17, 2020 by Resolution No. R-312895; and

WHEREAS, since that time, the California Governor, the County of San Diego Public Health Official (Public Health Official), and the Mayor have all issued directives and guidance to state and local residents to stay home or at their place of residence, except as needed to maintain continuity of operations of the federal critical infrastructure sectors; and

WHEREAS, the Centers for Disease Control and Prevention and the Public Health Official have issued public health guidance related to the operation of shelters and addressing unsheltered homeless populations in light of the COVID-19 threat, including guidance to implement social distancing and housing the unsheltered population; and

WHEREAS, the Centers for Disease Control and Prevention considers the virus to be a very serious public health threat; and

WHEREAS, conditions of disaster or extreme peril to the safety of persons and property continue to directly affect the safety of persons and property within the City; and

WHEREAS, California Government Code section 8630 authorizes local governing bodies to proclaim local emergencies when such events occur as are defined by California

Government Code section 8558(c), provided further by section 8630 that the local governing body must review the state of emergency at least every thirty days until the emergency is declared to be terminated and shall proclaim the termination of the local emergency at the earliest possible date that conditions warrant; and

WHEREAS, the City Council declared a continued state of local emergency in the City of San Diego on April 14, 2020, on May 12, 2020, and on June 9, 2020; and

WHEREAS, since the last extension of the state of local emergency, COVID-19 has continued to spread and impact nearly all sectors of California and the State of Emergency has continued at the State level; and

WHEREAS, the Governor has identified the State's path forward from the stay-at-home order in California's Pandemic Roadmap, which provides for an easing of the stay-at-home restrictions at Stage 4; and

WHEREAS, as of June 18, 2020, the County of San Diego is moving through Stage 2 and toward Stage 3 of the Roadmap, with State orders in effect to continue to practice safe-distancing and wear masks in public places and indoors where safe-distancing cannot be observed, NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that pursuant to California Government Code section 8630, a state of local emergency is declared to persist in the City of San Diego.

BE IT FURTHER RESOLVED, that the Council hereby ratifies and approves, in accordance with the police powers vested in City Officials under the Constitution of the State of California, the City Charter, and the laws of this State including the aforementioned Government Code provisions, all orders and regulations promulgated, issued and carried out by City officers

and City officials from February 14, 2020, until the passage of this resolution, which were necessary to provide for the protection of life and property.

BE IT FURTHER RESOLVED, that during the existence of this local emergency, the powers, functions and duties of the Mayor of this City shall be those prescribed by State law and the Charter, ordinances, resolutions and approved plans of the City of San Diego in order to mitigate the effects of this local emergency, including the receipt, processing, and coordination of all inquiries and requirements necessary to obtain available state and federal assistance.

BE IT FURTHER RESOLVED, that the state of local emergency shall be deemed to continue until its termination is proclaimed by the City Council.




