DATE OF FINAL PASSAGE OCT 23 2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR, ACCEPT, APPROPRIATE AND EXPEND \$2,000,000 IN GRANT FUNDING AND ANY ADDITIONAL FUNDING MADE AVAILABLE FROM THE OFFICE OF JUVENILE JUSTICE AND DELINQUENCY PREVENTION INTERNET CRIMES AGAINST CHILDREN TASK FORCE PROGRAM FOR A PERIOD OF UP TO FIVE YEARS.

WHEREAS, the San Diego Police Department (Police Department) investigates crimes involving online child victimization; and

WHEREAS, the Internet Crimes Against Children (ICAC) Task Force Program is a national network of sixty-one coordinated local tasks forces, representing over 4,500 federal, state, and local law enforcement and prosecutorial agencies; and

WHEREAS, the Police Department administers the regional San Diego ICAC Task Force Program; and

WHEREAS, the Office of Juvenile Justice and Delinquency Prevention (OJJDP) provides grant funding to help state and local law enforcement agencies develop an effective and sustainable response to technology-facilitated child sexual exploitation and internet crimes against children; and

WHEREAS, the Police Department has participated in the ICAC Task Force Program since 2000; and

WHEREAS, the Council most recently authorized ICAC grant funding for a five-year period in San Diego Resolution R-310039 (November 3, 2015); and

WHEREAS, the Police Department and San Diego ICAC Task Force Program desire to continue the OJJDP ICAC program through grant funding; and

WHEREAS, grant funding will continue to be used by the San Diego ICAC Task Force to conduct criminal investigations, provide forensic resources, respond to referrals and tips, participate in nationally coordinated investigations, obtain and provide equipment, and conduct training, outreach, prevention, and educational community activities; and

WHEREAS, the Police Department now seeks authority to apply for, accept, appropriate and expend grant funding from the OJJDP ICAC Task Force Program; and

WHEREAS, the initial grant award in Fiscal Year 2021 is anticipated to be \$2,000,000, with additional funding possible; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized, on behalf of the City to apply for and accept \$2,000,000 and any additional grant funding authorized by the OJJDP ICAC Task Force Program, including any amendments, extensions, or renewals of the grant, for a period of up to five years, for the purpose of implementing the ICAC Task Force Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Fiscal Year 2021 Budget, and to accept, appropriate and expend \$2,000,000 and any additional grant funding authorized by the OJJDP ICAC Task Force Program, including any amendments, extensions, or renewals of the grant, for a period of up to five years, for the purpose of implementing the ICAC Task Force Program.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to enter into all agreements and certifications necessary for the purpose of implementing the ICAC Task Force Program.


