DATE OF FINAL PASSAGE **OCT 23 2020**

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR, ACCEPT, APPROPRIATE AND EXPEND \$138,204 IN GRANT FUNDING AND ANY ADDITIONAL FUNDING MADE AVAILABLE FROM THE CALIFORNIA DEPARTMENT OF JUSTICE SEXUAL ASSAULT EVIDENCE SUBMISSION PROGRAM FOR A PERIOD OF UP TO FIVE YEARS.

WHEREAS, the San Diego Police Department Crime Laboratory (Crime Laboratory) processes sexual assault evidence; and

WHEREAS, the Crime Laboratory has processed sexual assault evidence for over forty years, and is progressive in adopting new technology as it develops; and

WHEREAS, as a leader in the forensic community regarding screening, analysis and interpretation of sexual assault evidence, the Crime Laboratory is constantly evaluating workflow and best approaches to processing evidence; and

WHEREAS, meeting changing legal requirements and community need for analyzing sexual assault evidence is one of the Crime Laboratory's highest priorities; and

WHEREAS, grant funding from the California Department of Justice Sexual Assault Evidence Submission Program will assist the Crime Laboratory in hiring and training staff, funding contractual services, obtaining additional instruments, and other activities, all with the goal of increasing testing capacity; and

WHEREAS, the initial award of grant funding is \$138,204, for a performance period of July 1, 2020 through June 30, 2022, with additional funding opportunities possible; and

WHEREAS, the Police Department now seeks authority to apply for, accept, appropriate and expend grant funding from the California Department of Justice Sexual Assault Evidence Submission Program for a period of up to five years; and

WHEREAS, approval by the Council is required by the terms of the grant; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized, on behalf of the City to apply for and accept \$138,204 and any additional grant funding authorized by the California Department of Justice Sexual Assault Evidence Submission Program, including any amendments, extensions, or renewals of the grant, for a period of up to five years, for the purpose of implementing the Sexual Assault Evidence Submission Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Fiscal Year 2021 Budget, and to accept, appropriate and expend \$138,204 and any additional grant funding authorized by the California Department of Justice Sexual Assault Evidence Submission Program, including any amendments, extensions, or renewals of the grant, for a period of up to five years, for the purpose of implementing the Sexual Assault Evidence Submission Program.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to enter into all agreements and certifications necessary for the purpose of implementing the Sexual Assault Evidence Submission Program.
