A RESOLUTION OF THE COUNCIL OF THE CITY OF

WHEREAS, on August 2, 2017, JOEY VAIASUSO DBA JETT GALLERY filed a claim against the City of San Diego [City] alleging property damage arising from a break in the City's water main at Kettner Boulevard and Juniper Street in Little Italy; and

WHEREAS, in Closed Session on September 15, 2020, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays, None; and absent, None, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$108,432.00 from Water Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the property damage claim filed by Joey Vaiasuso DBA Jett Gallery.

2. Authorizes the Chief Financial Officer to expend \$108,432.00 from Water Fund

No. 700011, for the purpose of settling this claim.


