DATE OF FINAL PASSAGE OCT. 30 2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR DESIGNEE TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE SAN DIEGO HOUSING COMMISSION FOR OVERSIGHT AND ADMINISTRATION OF THE COORDINATED STREET OUTREACH PROGRAM.

WHEREAS, the 2020 homelessness census known as the Point-in-Time Count indicated that 4,887 individuals were experiencing homelessness in the City of San Diego (City), representing 64% of all homeless individuals counted in the County of San Diego; and

WHEREAS, the 2020 Point-in-Time Count indicated 2,283 individuals, or 47% of the City's homeless population, were identified as being unsheltered and residing in locations not meant for human habitation; and

WHEREAS, a primary means of connecting those living in unsheltered environments is through outreach services; and

WHEREAS, the City, through contracts administered by the San Diego Housing Commission (Commission) with service providers, has in recent years increased its investment in outreach services and desires to further expand its efforts; and

WHEREAS, on June 8, 2020, as part of the Fiscal Year 2021 City Budget approval, the City allocated \$1,500,000 for the purpose of providing additional outreach services within the City, under Resolution No. R-313071; and

WHEREAS, the City and the Commission desire to enter into a Memorandum of Understanding to memorialize the agreement between the parties for the administration of the contract with a service operator for additional outreach services and the coordination of outreach services; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or designee, is authorized to enter into a Memorandum of Understanding between the City of San Diego and the San Diego Housing Commission for the oversight and administration of outreach services, in substantially the form attached to Housing Authority Report No. HAR 20-036.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,077,643 in Fiscal Year 2021 from the General Fund, Homelessness Strategies Department budget, contingent on the Chief Financial Officer certifying that the funds necessary for the expenditure are, or will be, available in the City treasury.


