A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FREEWAY AGREEMENT WITH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR STATE ROUTE 163.

WHEREAS, Caltrans has requested the City to enter into a new Freeway Agreement for a segment of State Route 163 (SR-163), beginning just south of Interstate 8 (I-8) and ending north of Genesee Avenue, to account for the Hazard Center Drive extension project, SR-163 Friars Road Interchange improvement, and the previously constructed SR-163/I-8 interchange improvements that are not accounted for in the existing Freeway Agreement; and

WHEREAS, the Hazard Center Drive extension project includes the construction of a two-lane road from the eastern terminus of Hazard Center Drive to the existing road behind Fashion Valley Shopping Center, which completes the missing segment of Hazard Center Drive and enhances traffic circulation in the community; and

WHEREAS, the recently completed SR-163 Friars Road Interchange improvement project includes widening the SR-163 Friars Road overcrossing from three to four lanes in each direction, improvements to the SR-163 on- and off-ramps, and bike and pedestrian improvements nearby; and

WHEREAS, besides these two City projects, Caltrans also previously updated the geometry of the I-8/SR-163 interchange to current standard configuration; and

WHEREAS, as a result of these changes within this segment of SR-163, Caltrans requires that the City enters into a new freeway agreement to reflect the new improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute and approve, for and on behalf of the City, the proposed State Route 163 Freeway Agreement with Caltrans to account for the Hazard Center Drive extension which passes under SR-163, the recently constructed SR-163 Friars Road Interchange improvement, and the previously constructed SR-163/I-8 interchange improvements that are not accounted for in the existing Freeway Agreement, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. RR-313285.
