A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN PLAINTIFFS-PETITIONERS, ASSOCIATED GENERAL CONTRACTORS OF AMERICA, SAN DIEGO CHAPTER, INC., ASSOCIATED GENERAL CONTRACTORS OF AMERICA, SAN DIEGO CHAPTER, INC., APPRENTICESHIP AND TRAINING TRUST FUND, AND THE CITY OF SAN DIEGO.

WHEREAS, on May 23, 2019, Plaintiffs-Petitioners, Associated General Contractors of America, San Diego Chapter, Inc., and Associated General Contractors of America, San Diego Chapter, Inc., Apprenticeship and Training Trust Fund (collectively "AGC"), filed suit against the City of San Diego challenging the 2019 bid specifications for the North City Pure Water Facility project. Specifically, AGC alleged the City's requirement that apprentices used on the project be registered in a Joint Labor Management Apprenticeship Program violated San Diego Municipal Code section 22.4402. The suit is entitled Associated General Contractors of America, San Diego Chapter, Inc. et al. v. City of San Diego et al., San Diego Superior Court Case No. 37-2019-00026631-CU-WM-CTL (hereafter "AGC's action"); and

WHEREAS, in closed session on September 29, 2020, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 8, and 9; Nays, 7; Absent, none, approved the Settlement of AGC's action for an amount consistent with the amount set forth below and pursuant to such other terms more fully set forth in a settlement agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$200,000.00 from Water Fund No. 700011, in settlement of each and every claim to costs and fees of any type, including attorneys' fees, against the City of San Diego, its agents and employees, arising from *Associated*

General Contractors of America, San Diego Chapter, Inc. et al. v. City of San Diego et al.,
Superior Court Case No. 37-2019-00026631-CU-WM-CTL.
