A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DESIGNATING THE 10300 BLOCK OF AVIARY DRIVE (INTERSECTION OF RED CEDAR DRIVE AND AVIARY DRIVE) TO BE KNOWN AS COL. ROBERT DINGEMAN DRIVE.

WHEREAS, pursuant to section 125.1130 of the San Diego Municipal Code, the City Council may designate sections of streets with honorary names to recognize and honor individuals and organizations who are of particular importance to the City of San Diego or who have made significant contributions to improve the quality of life in the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- (1) That the limit of honorary street name designations per councilmember in Council Policy 200-10 is hereby waived for this action; and
- (2) That the 10300 block of Aviary Drive between the intersections of Red Cedar Drive and Aviary Drive located in the Scripps Ranch community is hereby designated as Col. Robert Dingeman Drive.


