A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AMENDMENTS TO THE GENERAL PLAN, DOWNTOWN COMMUNITY PLAN, AND LOCAL COASTAL PROGRAM FOR THE TAILGATE PARK LAND USE AMENDMENTS.

WHEREAS, on January 30, 2020 the Planning Commission voted 5-0-2 to initiate amendments to the General Plan, Downtown Community Plan, Centre City Planned District Ordinance, and the Local Coastal Program ("Amendments") with respect to two blocks bounded by Imperial Avenue and K, 13th and 14th streets ("Site") in the East Village Neighborhood of the Downtown Community Plan area ("Downtown"); and

WHEREAS, the Amendments include changing the land use district from Mixed

Commercial to Ballpark Mixed-Use for the Site, changing the overlay district for the northern

block of the Site from Fine Grain to Large Floorplate; and, amending the floor area ratio (FAR)

limits on the Site consistent with those in the Ballpark Mixed Use district; and

WHEREAS, the City of San Diego ("City") wishes to have uniform land use regulations for the Tailgate Park property to facilitate the proper redevelopment of the site consistent with the goals and policies of the Downtown Community Plan; and

WHEREAS, on September 10, 2020, the Planning Commission voted 7-0 to support the proposed Amendments; and

WHEREAS, the matter was set for public hearing on November 10, 2020, testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that the amendments to the General Plan, Downtown Community Plan, and Local Coastal Program, a copy of which is on file in the office of the City Clerk as Document No. RR-313333, are hereby approved.
