A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
REBECCA LIMON AND THE CITY OF SAN DIEGO

WHEREAS, on November 13, 2017, REBECCA LIMON filed a lawsuit against the City of San Diego and San Diego Police Department [City] alleging personal injuries from an employment matter that occurred June 30, 2017, entitled *Rebecca Limon v City of San Diego, et al.* San Diego Superior Court Case No. 37-2017-00043294-CU-WT-CTL; and

WHEREAS, in Closed Session on October 27, 2020, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 8, and 9; Nays, None; and absent, 7, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$425,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the lawsuit *Rebecca Limon v. City of San Diego*, San Diego Superior Court Case No.: 37-2017-00043294-CU-WT-CTL.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$425,000.00 from the Public Liability Fund No. 720045, for the purpose of settling this claim.




