A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING CHANGE ORDER NO. 5
FOR WATER GROUP 939.

WHEREAS, Water Group 939 (Project) is currently under construction with James W. Fowler contracted to install and repair water mains in the Torrey Pines and University community; and

WHEREAS, during construction of the tunneled water main installation within the Project, the micro-tunneling boring machine (MTBM) encountered heavy timbers which damaged and disabled the MTBM, and will require repair by the manufacturer to continue with the construction and further unforeseen conditions; and

WHEREAS, Change Order No. 5 is for additional construction work required for the tunneled water main installation for an amount not to exceed \$1,400,000; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized to execute Change Order No. 5, on file with the Office of the City Clerk as Document No. RR- 313348, issued in connection with the contract between the City of San Diego and James W. Fowler to increase the contract price to an amount not to exceed \$1,400,000, and an extension of 65 working days for a total of 487 working days.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an additional amount not to exceed \$1,400,000 from CIP A-KB.00003, Main Replacements (B-11035 - Water Group 939), Fund 700010, Water Utility CIP for Change Order No. 5 for construction of the Project, contingent upon the Chief Financial Officer issuing one or more

certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.




