A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING CHANGE ORDER NO. 3  
FOR 30TH STREET PIPELINE REPLACEMENT  
PROJECT.

WHEREAS, 30th Street Pipeline Replacement Resurface project (Project) is currently under construction with Ortiz Corporation contracted to repair water mains and related work in the North Park community; and

WHEREAS, during construction of the Project it was determined that additional resurfacing was necessary to the streets, roadways and bicycle facility locations within the Project, and it was determined that the improvements would be more economical and minimize the impacts to the community to complete the improvements within the Project; and

WHEREAS, Change Order No. 3 is for additional resurfacing and related bicycle improvements for an amount not to exceed \$2,600,000; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized to execute Change Order No. 3, on file with the Office of the City Clerk as Document No. RR- 313350, issued in connection with the contract between the City of San Diego and Ortiz Corporation to increase the contract price to an amount not to exceed \$2,600,000, and an extension of 60 working days for a total of 720 working days.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an additional amount not to exceed \$2,600,000 from S-12010 – 30th Street Pipeline Replacement, Fund 700010, Water Utility CIP; AID-00005, Street Resurfacing and Reconstruction (B-21018 – 30th St. Pipeline Replacement Resurface), Fund 200203, Trench Cut

Fees/Excavation Fee; and AIA-00001, Bicycle Facilities (B-21019 – 30th St. Bike Lane Improvements), Fund 400169, TransNet Extension 70% Cap, for Change Order No. 3 for construction of the Project, contingent upon the Chief Financial Officer issuing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.




