WHEREAS, in preparation for the U.S. Open, the City is moving forward with the construction of a temporary driving range between holes 1 and 18 on the North Golf Course at Torrey Pines; and

WHEREAS, in order to meet the tournament timeline, the temporary driving range must be completed by March 18, 2021; and

WHEREAS, this City Council action would authorize the transfer of \$950,000 in Capital Improvements Program funds for the purpose of construction of the Torrey Pines Golf Course Temporary Driving Range; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to transfer \$950,000 from CIP AEA00001, Torrey Pines Golf Course, to CIP S18002, TP South Golf Course Imp Renovation, within Fund 70045, Torrey Pines Golf
