A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO ADOPTING THE 2021 LEGISLATIVE  
CALENDAR AND THE FISCAL YEAR 2022 BUDGET  
DEVELOPMENT AND FISCAL YEAR 2021 BUDGET  
MONITORING KEY DATES.

WHEREAS, each year, the City Council adopts a schedule of meetings for the City Council and Standing Committees of the City Council for the calendar year, commonly referred to as the legislative calendar; and

WHEREAS, the Council also desires to schedule the meetings of the Budget Review Committee and adopt a calendar that includes the meetings of the Housing Authority; and

WHEREAS, the Council desires to adopt a schedule for the Fiscal Year 2022 Budget Development and Fiscal Year 2021 Budget Monitoring Key Dates; and

WHEREAS, the Legislative Calendar will be amended after adoption to reflect the current Temporary Rules of Council, adopted on June 9, 2020 by Resolution No. R-313082, established to accommodate the change in meeting procedures during the COVID emergency, for the duration of the Governor's Executive Orders N-25-20 and N-29-20, unless earlier terminated by the City Council; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the schedule of meetings for the City Council, Standing Committees, and Budget Review Committee of the City

Council, which includes meetings of the Housing Authority, for the period of January 1, 2021 through December 31, 2021, a copy of which is on file in the Office of the City Clerk as Document No. RR- **313388-1**, is hereby adopted.

BE IT FURTHER RESOLVED, that the Fiscal Year 2022 Budget Development and Fiscal Year 2021 Budget Monitoring Key Dates, as approved by the Budget and Government Efficiency Committee, a copy of which is on file in the Office of the City Clerk as Document No. RR-**313388-2**, is hereby adopted.
