A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING SUBMITTAL OF
APPLICATIONS TO CALRECYCLE FOR THE BEVERAGE
CONTAINER RECYCLING CITY/COUNTY PAYMENT
PROGRAM AND RELATED ACTIONS.

WHEREAS, pursuant to Public Resources Code sections 14500 *et seq.*, the California Department of Resources Recycling and Recovery (CalRecycle) has established the Beverage Container Recycling City/County Payment Program (Program) to make payments available to support the beverage container recycling and litter cleanup activities of qualifying jurisdictions; and

WHEREAS, in furtherance of this authority, CalRecycle has established procedures governing the administration of the Beverage Container Recycling City/County Payment Program; and

WHEREAS, CalRecycle's procedures for administering the Beverage Container Recycling City/County Payment Program require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of the Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or designee, is authorized to submit applications for the Beverage Container Recycling City/County Payment Program to CalRecycle on behalf of the City of San Diego for Fiscal Year 2020/2021 through and including Fiscal Year 2024/2025 to receive payments to support the City's beverage container recycling and litter cleanup activities.

2. That the Mayor, or designee, is authorized and empowered to negotiate and execute, for and on behalf of the City, all Program-related documents, including applications, agreements, payment requests, annual reports including expenditure reports, and amendments necessary to secure Program payments, implement and close out the Program, and administer the City's obligations, responsibilities, and duties under the terms and conditions of the Program for awards received for Fiscal Year 2020/2021 through and including Fiscal Year 2024/2025.

3. That, for the purposes of this Program, the Mayor's designee includes the Environmental Services Department Director and Deputy Director.

4. That the Chief Financial Officer is authorized to accept, appropriate, and expend Program payments from the Grant Fund Enterprise State (No. 710001) to support the City's beverage container recycling and litter cleanup activities, contingent upon securing Program funding and execution of Program agreements.
