DATE OF FINAL PASSAGE JAN 15 2021

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXTENDING FRANCHISE OF SAN DIEGO GAS & ELECTRIC COMPANY TO CONSTRUCT, USE, AND MAINTAIN PIPES AND APPURTENANCES IN THE STREETS OF THE CITY OF SAN DIEGO FOR THE TRANSMISSION AND DISTRIBUTION OF GAS TO CUSTOMERS INSIDE AND OUTSIDE THE CITY.

WHEREAS, by San Diego Ordinance O-10465 effective on January 17, 1971 (Ordinance O-10465), the City of San Diego (City) granted to San Diego Gas & Electric Company (SDG&E) a 50-year franchise to construct, use, and maintain pipes and appurtenances in, on, and under the streets of the City for the purpose of transmitting and distributing gas to customers inside and outside the City (Gas Franchise); and

WHEREAS, in anticipation of the expiration of the Gas Franchise, the City in 2019 commenced a process for the advertisement and award of a new gas franchise; and

WHEREAS, the process of letting a new gas franchise cannot be culminated prior to the expiration of the existing Gas Franchise; and

WHEREAS, both the City and SDG&E desire to extend the term of the existing Gas Franchise for a period of 135 days through June 1, 2021, under the same terms and conditions to provide time for the culmination of the process of letting a new gas franchise or further extending and or amending the existing Gas Franchise; NOW, THEREFORE,

BE IT ORDAINED by the Council of the City of San Diego that:

Section 1. The term of the Gas Franchise granted to San Diego Gas & Gas Company by Ordinance O-10465 on December 17, 1970, as amended by San Diego Ordinance O-19031 (Ordinance O-19031) on January 14, 2002, to construct, use, and maintain pipes and

appurtenances in, on, and under the streets of the City for the purpose of transmitting and distributing gas to customers inside and outside the City, is hereby and extended for a period of 135 calendar days commencing on January 18, 2021 through June 1, 2021, and the San Diego Gas & Gas Company shall be deemed to have been granted a franchise for said purposes for that period of time.

Section 2. The terms and conditions of the franchise granted and extended by Section 1 of this ordinance shall be identical to and the same in every respect as the terms and conditions in the Gas Franchise granted by Ordinance O-10465 on December 17, 1970, as amended by Ordinance O-19031 on January 14, 2002.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
