DATE OF FINAL PASSAGE APR 22 2021

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE EXECUTION OF THE
JOINT USE AGREEMENT FOR PACIFIC TRAILS MIDDLE
SCHOOL AND CANYON CREST ACADEMY WITH THE
SAN DIEGUITO UNION HIGH SCHOOL DISTRICT.

WHEREAS, the San Dieguito Union High School District (District) owns Pacific Trails Middle School located at 5975 Village Center Loop Road, and Canyon Crest Academy located 5951 Village Center Loop Road (collectively the "Schools"), within the Pacific Highlands Ranch Community in the City of San Diego (City); and

WHEREAS, the City and the District desire to enter into an agreement that will allow for City operation, maintenance, and use of approximately 29.02 acres of irrigated natural turf field, running track, access drive, parking lots, frontage area and associated infrastructure at the Schools for an initial term of 10 years and five options to renew, with each option having a term of 10 years, at the City's sole discretion and without further action by the Council of the City of San Diego (Council) or the Board of Trustees of the District to exercise such renewal; and

WHEREAS, the design and construction of the proposed joint use facilities at the Schools will be funded by the District; and

WHEREAS, under San Diego City Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by ordinance approved by a two thirds' majority vote of the Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego (Council), as follows:

Section 1. That the Mayor, or his designee, is hereby authorized and directed to execute the Pacific Trails Middle School Joint Use Agreement, on file in the office of the City Clerk as

Document No. OO- 21310, between the City of San Diego and the San Dieguito Union High School District, for the joint use of a portion of Pacific Trails Middle School and Canyon Crest Academy.

Section 2. That a full reading of this Ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
